CTTP is a collective of various sovereign Northern California Tribal nations offering Temporary Assistance to Needy Families (TANF) in approximately fifteen (15) counties in Northern California, and is governed by the Robinson Rancheria Citizen Business Council. The goal of the CTTTP Program is to provide temporary assistance and services to Native Families while developing strategies to establish long term self-sufficiency for each family. The nature and Spirit of the CTTTP Program is to provide services to Native families that promote and stimulate their economic growth while recognizing and incorporating cultural identities as well as customs. CTTTP is funded by Federal and State grants under the Administration for Children and Families.
